### **PERSONAL NOTE FROM THE CHAIRMAN**

The Viet Nam Veterans and Their Families Trust is getting up and running. We can't avoid the up-front administrative work that has to be completed for a Trust that is intended to be in place for 30 years. This ranges from investment and banking arrangements to information for beneficiaries and welfare officers.

At the same time the trustees know that many Viet Nam veterans and their families have been waiting a long time for some tangible help. We are therefore providing an opportunity now for Veterans and family members to make applications to the Trust for financial assistance. We will turn these around quickly.

Attached is an outline of the basic, minimum information we will need, to consider a request for assistance, and where this should be sent.

Please note:

We will give priority in the first instance to cases where there is immediate or obvious need or hardship.

If a veteran or family member has a good case that meets the Trust criteria they won't miss out if they decide to wait until we have more information out through the veterans' networks in the next couple of months, and put up a more thorough or detailed application.

If a veteran or family member does apply now, and gets something from the Trust, this won't disqualify them from getting something further from the Trust if they have a good case.
